ENROLLMENT CONDITIONS FOR STUDENTS

FOR THE 2025/2026 ACADEMIC YEAR

1. Students enrolled in the integrated academic studies of veterinary medicine in English at the Faculty of Veterinary Medicine, University of Belgrade, are admitted exclusively as self-financed students throughout their studies.
2. Based on the Decision of the Senate of the University of Belgrade No. 06-2875/3-2025 dated October 1, 2025, students in the 2025/2026 academic year may be approved to enroll in up to 90 ECTS credits. This total includes credits from both newly taken subjects and obligations, as well as those previously attended but not passed or completed in past academic years.
In cases where a student needs only to enroll in the final thesis after already enrolling in 90 ECTS credits, the student may be allowed to exceed 90 ECTS credits at their request (to include the thesis credits).
3. To enroll in a higher year of study (second, third, fourth, fifth, or sixth year), a student must enroll in at least 37 ECTS credits from that higher year.
4. When selecting courses, both budget-funded and self-financed students must first select all courses from the second year before choosing courses from the third year, select all third-year courses before enrolling in fourth-year courses, and so on (Rulebook on Integrated Academic Studies of the Faculty of Veterinary Medicine, No. 01-290 dated March 22, 2023, Article 26).
5. A student who does not pass a required course or complete mandatory practice before the start of the next academic year must re-enroll in that same required course or practice. A student who does not pass an elective course before the next academic year may either re-enroll in the same elective course or choose another elective (Law on Higher Education of the Republic of Serbia, 19/2025, Article 102).
6. Students who have been granted a suspension of rights and obligations (status of dormancy) are not allowed to take exams or attend classes during the period of dormancy (Statute of the University of Belgrade, Article 100, 262/25).

TUITION FEES FOR THE 2025/2026 ACADEMIC YEAR

1. Tuition for self-financed students enrolling in the first year of study for the first time is €5,000.00. payable in Serbian dinars at the exchange rate on the payment date.

2. Tuition for self-financed students in higher years of integrated studies in English is calculated by multiplying each credit point for newly enrolled subjects by €83.33 and each credit point for carried-over subjects by €50.00. This applies to all subjects and each academic year as well as the thesis.
3. Tuition can be paid in four installments. The first installment must be visible in the FIS system at the time of enrollment. The second installment must be paid before the February exam registration period, the third before the May exam registration period, and the fourth before the September 1 exam registration period in 2026. Payments must be made via student accounts in the FIS system. Foreign students studying in Serbian must bring a payment slip for each tuition installment to the Student Services Office.
4. At the time of enrollment, students must provide proof of payment of a fee of 300.00 RSD for the Center for Career Development (payment account: 840-1825666-41, reference number 200-5). This fee is subject to adjustment in accordance with the University's decision.
