The administration of the entrance exam in the first enrollment period at the Faculty of Veterinary Medicine, University of Belgrade, began and concluded according to the established plan on June 25th, 2024.

Only one candidate applied for studies in veterinary medicine in English and participated in the entrance exam. The exam took place in the facilities used by the Department of Pathology. The examination proceeded smoothly without any objections from the candidate.

Based on the information provided and in accordance with the Admission Competition for the first year of undergraduate and integrated studies, a PRELIMINARY RANKING LIST has been determined for the first enrollment period in 2024, after adding up the points obtained based on high school performance and the entrance exam.

The candidate has the option to file a complaint regarding the regularity of the admission procedure, the regularity of the entrance exam, or their position on the preliminary ranking list within 36 (thirty-six) hours from the publication of the faculty's preliminary ranking, but not later than June 27th 2024 at noon.

Complaints are submitted to the faculty commission responsible for admissions, which will make a decision on the complaint within 24 hours of receiving it, but no later than July 1st 2024 by 12 p.m..

The candidate also has the opportunity to file a secondary appeal to the dean of the faculty within 24 (twenty-four) hours after the expiration of the deadline for the commission's decision on the candidate's complaint.

The dean will make a decision on the appeal within 24 (twenty-four) hours after receiving it. but not later than July 2nd 2024.
After resolving the received appeals and complaints, the Faculty will establish and publish the FINAL RANKING LIST.

The FINAL RANKING LIST will be published no later than July 2nd, 2024, at 15:00.
